Re: One Time Relaxation in Eligibility Conditions of Club Membership for M.Y.2025-26

The Competent Authority has approved relaxation in the eligibility conditions for Continuation in M.Y. 2025-26 under ELITE/Corporate/Club Galaxy/Chairman's/Zonal Manager's/Divisional Manager's/Branch Manager's and Distinguished Clubs, for the Qualifying Financial Year 2024-25.

This Relaxation shall be applicable for Qualifying F.Y. 2024-25 (M.Y. 2025-26) only. This is a one time concession and it shall not be treated as a precedent.

The relaxation in eligibility criteria will be as follows:

- 1. Agents who were Club Members during M.Y.2024-25 but could not fulfill the Eligibility Criteria in Qualifying Financial Year 2024-25 for continuation in the same club for the M.Y.2025-26, all such Agents will be allowed to continue notionally in the same club for the M.Y.2025-26 in spite of the shortfall in any of the eligibility conditions i.e. Minimum Net Number of Lives/Net Number of Lives/Renewal Commission/First Year Commission in Qualifying Financial year 2024-25. However, it may be noted that there is no relaxation in lapsation
- 2. This relaxation will be applicable only for the **continuation** in the same club for the M.Y.2025-26.
- 3. For becoming eligible to further continue their Club Membership for M.Y. 2026-27, the agents would have to cover shortfall as well as regular business criteria of the concerned club during F.Y. 2025-26. The business done/commission earned during F.Y 2025-26 shall be apportioned in the following order of priority:
 - a) Covering shortfall of Qualifying F.Y.2024-25.(M.Y.2025-26)
 - b) Remaining business/commission towards Qualifying F.Y. 2025-26 (M.Y.2026-27).
- 4. Club Member Agents fulfilling the required business in F.Y.2025-26(equal to shortfall plus required criteria to become eligible for continuation in M.Y.2026-27) shall become eligible for all the monetary benefits for both the $M.Y.2025\mbox{-}26$ and $M.Y.2026\mbox{-}27$ as eligible for the respective club.
- 5. Club Member Agents who are <u>notionally</u> allowed to continue as above will <u>not</u> be eligible for any monetary benefits such as office allowance, Business Procurement Expenses, computer allowance, telephone/mobile expenses, sales promotional gift items, supply of visiting cards, envelopes, letter heads, fresh Interest Free Advances, Group Insurance, Mediclaim, Housing loan etc. as applicable to respective Club till the finalization of club membership of MY 2026-27. They will also not be eligible to attend club convention. However, they are entitled for all the functional privileges applicable for their respective Club.
- 6. Any such agent working as CLIA will be allowed to continue to act as CLIA till finalization of Club Membership of MY 2026-27.





7. The Club Member Agents covering **ONLY** the shortfall in business during F.Y.2025-26 will be considered for the club eligibility for continuation in the club for M.Y.2025-26 only and accordingly, monetary benefits would be payable for one Membership Year only.

Accordingly, if a Club Member Agent had been sanctioned Interest Free Advance, the same will continue to remain interest free only till such time he/she continues to be a Member of eligible club i.e. upto 31.08.2026.

- 8. If a Club Member Agent is not able to make good the shortfall in F.Y.2025-26 and does not qualify for continuance of membership in the same club and therefore may either be relegated to lower club or will not qualify for any club, then the interest free advance shall be reviewed in the following manner:
 - (a) Eligible quantum of interest free advance under relegated lower Club/No club to be reckoned as on 01.09.2025.
 - (b) Amount of outstanding advance as on the date of cessation of membership i.e. on 01.09.2025.
 - (c) The excess of **(b)** over **(a)** shall be treated as with interest advance and interest @ 9% per annum payable half yearly or any other rate that may be decided by the Corporation will be charged w.e.f.01.09.2025.

In such cases, monetary benefits for the respective lower club will be payable for M.Y.2025-26. Needless to add that if an agent does not qualify for any club, no monetary benefits will be payable.

- All existing Club Members, who avail above concessions and become eligible to continue in the same club for M.Y.2026-27 shall be deemed to be continuing as Club Member Agents without break.
- 10. Illustration on covering the shortfall and required business parameters in F.Y.2025-26 are as mentioned below:


